  - b. The event described herein is completely cancelled, and a minimum of 60 days notice is given.
4. In the event that **Baker's Music & Video** becomes unable to provide his services due to complications beyond his control, a reputable replacement shall be provided at no more than the original price agreed on.
5. Any and all information or details must be communicated before the 5 days preceding the performance.
